objection certificate application has been submitted by you to the government on the basis of wrong information or the instructions issued by the Government of Punjab from time to time are not being complied with by you and as such the conditions mentioned in written in the affidavit have not been agreed to, then under such a circumstance this no objection certificate can be taken back at any time.

2. Teaching of Punjabi up to matriculation level shall be compulsory in your school. C.B.S.E. shall definitely make out efforts to conduct examination of Punjab in such schools and simultaneously it is also conferred upon that in case of not doing so no objection certificate shall immediately be taken back.
3. After obtaining approval of affiliation to C.B.S.E. the management of the school shall be bound to give pay and other allowances to the teaching and non teaching staff of the school alike government employees. In case of not doing so no objection certificate shall immediately be taken back.
4. You yourself and your management shall make it sure that whenever any kind of information is called for by the District Education Officer of your District
